■Premium reduction business using receipts

A gift certificate or electric money (points) equivalent to 3,000 yen per household will be awarded for

spending money at shops within Kagoshima City between October 1st and December 28th 2022

Application Deadline: Postmarked by December 28th

How to apply: Attach receipts worth 10,000 yen or more to the application form (which has already been sent out) and apply either via mail or online.

■ Special benefits to support households raising children (Just for Kagoshima City)

10,000 yen per child will be sent to households with children who were born between April 2<sup>nd</sup>, 2004 and March 31<sup>st</sup>, 2021 and have guardians who live in Kagoshima City as of September 30<sup>th</sup> of this year.

How to apply: There is no need for those already receiving childcare benefits to apply, as those already receiving childcare benefits are set to receive a direct deposit to their bank account in late December.

Application is required for households with only high school-aged children, households of civil servants or households with an income that exceeds the maximum required to receive childcare benefits. An application form is scheduled to be sent out to households with children registered as residents of Kagoshima City on Friday, December 9<sup>th</sup>. (Applications will start to be accepted on the same day)

MSpecial benefits livelihood support for households raising children

50,000 yen per child will be distributed to low-income households that are raising children.

- For single-parent households
  - ① Those who did not receive childcare benefits due to receiving pension, etc.
- 2 Those whose income decreased to the same level as those receiving childcare benefits due to the impact of COVID-19
- · For other households
  - Those exempt from resident taxes who are raising children born in April 2022 or later (the child's first resident registration must be in Kagoshima City)
  - ④ Of those raising children who are not in situation 3, those who are exempt for resident taxes this year and those whose income has decreased to the same level as resident tax-exempt people due to the impact of COVID-19.
  - ♦ There is no need for those in situation 3 to apply. For those in situations 1, 2 and 4, applications are due on February 28<sup>th</sup>, 2022.

## Childcare guide

■2023 Applications for nurseries and certified centers for early childhood education and care (that function

as nurseries)

Eligible: Guardians who cannot watch over their children due to work, pregnancy/giving birth, illness, searching for employment

\*Those who were on the waiting list for 2022 still need to reapply

Application period: Period 1 by December 23rd

Period 2 from December 26th to February 8th

Period 3 from February 9<sup>th</sup> to March 8<sup>th</sup> (After that, applications will be accepted at any time)

#### ■Newborn visits

Childcare consultations conducted by midwives and nurses via home visits

Eligible: As a rule, mothers of children 28 days old or younger and their child. For more details, contact the Mother and Child Public Health Division at 216-1485.

### ■ Assistance with children's medical costs

For children in their 3<sup>rd</sup> year of middle school or younger (or children 18 or younger for households exempt from resident taxes)

#### ♦Amount granted

For the cost of appointments partially covered by insurance, the full cost will be covered for children ages 2 and younger, and 2000 yen will be reduced from the total cost per month for children ages 3-third year of middle school (Households exempt from resident taxes receive support for the full cost)

- ♦ Partial payment of health care services provided through health insurance for children of households exempt from resident taxes is not required at medical institutions within Kagoshima Prefecture
- ◇Procedures are required if you do not have a card saying that you receive assistant or there has been a change to your situation

### Necessary documents for exemption from social insurance premiums

Receipts or other documents showing the amount paid are required in order to receive a deduction for social insurance premiums when making year-end adjustments, filing final tax returns, or filing city or prefectural tax returns.

- National Health Insurance Tax: National Health Insurance Division (Tel:216-1230)
  - •Those who paid National Health Insurance Taxes this year Notice of annual payment amount to be sent by the city in late January 2023.
  - ♦ If needed early, we will issue a health insurance tax contact form (free of charge) for filing.
  - A tax payment certificate (300 yen) is required when filing a tax return to a tax office outside the city.
  - ♦ Please send an application to receive a proposed payment amount for each household member (excluding the special levy).
- Nursing-care Insurance fees Nursing-care Insurance Division (Tel:216-1279)
  - Those who pay by special collection (payment from pension)
     Certificate of Withholding Tax for Public Pension and Other Benefits to be sent by the pension insurer in late January 2023
  - Those who pay by ordinary tax collection (payment slip or bank account transfer)

    Notice of annual payment amount to be sent by the city in late January next year.
- ♦ Starting this year, we will also send notifications of the annual payment amount to those who have paid with a payment slip.

- ♦ If you need to pay early, the Nursing-care Insurance Division or the counter in charge at each branch office will issue a confirmation of payment.
- Late-stage medical insurance premiums for the elderly: Longevity Support Section (Tel:216-1268)
  - Those who pay by special collection (payment from pension)
     Certificate of Withholding Tax for Public Pension and Other Benefits to be sent by the pension insurer in late January 2023
  - Those who pay by bank account transfer
     Notice of account transfer and automatic payment of late-stage medical insurance premiums for the elderly to be sent by the city in late January 2023
    - If the premiums are transferred from an account in a name other than your own, the deduction for social insurance premiums will be applied to that name.

    - ◇If you have lost it, the Longevity Support Division or the counter in charge at each branch office will issue a confirmation of payment.
